- 4. I understand that a confirmation of a booking a confirmation voucher is issued and no request for transfer, change or amendment as to the CV shall be entertained by ESL.
- 5. I understand that renting/commercial usage of ESLM /holidays is not allowed.
- 6. I understand that the number of people who can occupy the Apartment is as follows:

Studio Apartment-2 Adults. If accompanied by extra adult, will be charged extra at 2500 with breakfast per adult.

- 7. General Dress Guidelines: Choose clothes appropriate for the senior living society.
  If your dress violates the standards listed in this policy, as determined by your manager and a representative of Edens group. Progressive disciplinary action applies for repeated violations.
- 8. I understand that any unutilized membership benefits shall automatically lapse at the expiry of the membership usage period.
- 9. I understand that the confirmation of any holiday booking will be subject to availability and eligibility holiday bookings open 4 months in advance.
- 10.
